The total JP wedding cost is three hundred dollars (\$300.00), which covers the Official, use of the facility and sound technician. A down payment of one hundred (\$100.00) is required to secure your special date. The funds (\$100.00) will go towards your three hundred dollars (\$300.00) fee.
